This tender is invited in 2 cover system from the registered and eligible firms through e-procurement portal of Government of Kerala (<https://www.etenders.kerala.gov.in>). Prospective bidders willing to participate in this tender shall necessarily register themselves with above mentioned e-procurement portal.

The tender timeline is available in the critical date section of this tender published in www.etenders.kerala.gov.in.

1. Online Bidder registration process:

- a. Bidders should have a Class II or above, Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on www.cca.gov.in. Once, the DSC is obtained, bidders have to register on www.etenders.kerala.gov.in website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.
- b. Bidders may contact e-Procurement support desk of Kerala State IT Mission over telephone at 0471-2577088, 2577188, 2577388 or 0484-2336006, 2332262 and through email: etendershelp@kerala.gov.in & eprocsupport.ker@nic.in for assistance in this regard.

2. Online Tender Process:

The tender process shall consist of the following stages:

- a. **Downloading of tender document:** Tender document will be available for free download on www.etenders.kerala.gov.in. However, tender document fee shall be payable at the time of bid submission as stipulated in this tender document.
- b. **Publishing of Corrigendum:** All corrigendum will be published on www.etenders.kerala.gov.in, which will be a part of the tender.
- c. **Bid submission:** Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document on www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.

- d. Opening of Technical Bid and Bidder short-listing:** The technical bids will be opened, evaluated and shortlisted as per the eligibility and technical qualifications. All documents in support of technical qualifications shall be submitted (online). Failure to submit the documents online will attract disqualification. Bids shortlisted by this process will be taken up for opening the financial bid.
- e. Opening of Financial Bids:** Bids of the qualified bidder's shall only be considered for opening and evaluation of the financial bid.

3. SUBMISSION PROCESS:

- a.** For submission of bids, all interested bidders have to register online as explained above in this document. After registration, bidders shall submit their Technical bid and Financial bid online on www.etenders.kerala.gov.in along with online payment of tender document fees and EMD.
- b.** For page by page instructions on bid submission process, please visit www.etenders.kerala.gov.in and click "Bidders Manual Kit" link on the home page.
- c.** It is necessary to click on "Freeze bid" link/ icon to complete the process of bid submission otherwise the bid will not get submitted online and the same shall not be available for viewing/ opening during bid opening process.

4. CATEGORIES OF BIDDERS FROM WHOM BIDS ARE SOLICITED:

Indian suppliers and Manufacturers of STATOR FRAMES WITH TERMINAL BOX FOR 25 kW ALTERNATOR.

5. ELIGIBILITY CRITERIA

Eligibility criteria to participate in the tender

- a.** The tenderer should be a manufacturer of Stator Frames with terminal box for 25 kW Alternator or an authorized trader of a manufacturer of Stator Frames with terminal box for 25 kW Alternator.
- b.** In case the bidder is a manufacturer, the manufacturer should have the capability to manufacture and supply of Stator Frames with terminal box for 25 kW Alternator. They should furnish evidence of sale of minimum numbers of Stator Frames with terminal box for 25 kW Alternator during any of the previous three financial years.
- c.** If the tenderer is an authorized trader of the manufacturer of Stator Frames with terminal box for 25 kW Alternator, the authorized trader should have supplied minimum number of Stator Frames with terminal box for 25 kW Alternator to industries during the previous three financial years. Proof of the same to be uploaded.

6. TECHNICAL SPECIFICATION OF STATOR FRAMES WITH TERMINAL BOX FOR 25 kW ALTERNATOR.

7. TECHNICAL BID/ COMMERCIAL BID

Technical bid proposal shall contain the scanned copies of the following documents which every bidder has to upload:

- i. Technical bid document duly filled, digitally signed and upload.
- ii. Notice Inviting Tender duly signed.
- iii. Tender Details duly signed.
- iv. Other Pre –Qualification Requirements

- Financial statements for the last two years
- GST registration details
- Company registration proof (CIN/valid certificate).
- Undertaking – no legal/vigilance/CBI cases (Annexure-I).
- Proof of experience – certificates/invoices/work orders.
- Self-certification – not blacklisted/debarred; no contract terminated/EMD forfeited.
- Banker's name, Account no. PAN card. etc.
(The bidders already registered as vendors of KEL for supply of stator frames with terminal box for 25 kW Alternator need not necessarily provide the pre-qualification documents)

8. PRICE BID

The Bidder shall upload the Price bid as per format given in cover 2:-

- a. The prices quoted shall be for SUPPLY OF STATOR FRAMES WITH TERMINAL BOX FOR 25 kW ALTERNATOR at KEL, Kundara Unit, Kollam District on for destination basis.
- b. The GST and any other statutory levies shall be clearly mentioned in the Price bid.
- c. The rate quoted in the BoQ shall be for one Nos only.
- d. The bidder shall upload the price break up sheet also in price bid.

9. Tender Document Fees and Earnest Money Deposit (EMD):

- a. The Bidder shall pay, Tender fee: ₹ 2,360/- ; EMD: ₹ 25,000/- to safeguard against bidder default.
- b. EMD of unsuccessful bidders will be refunded automatically; for successful bidders, refund is after submission of Security Deposit (SD).
- c. Successful bidders must submit SD of 5% of contract value within 10 days (via DD or Bank Guarantee).
- d. SD is waived for existing suppliers and must be revised if contract value increases.
- e. SD bears no interest and may be adjusted or forfeited for non-performance, delays, or risk purchase.
- f. SD will be refunded only after full contract completion.

- g. The requirement of Security deposit is waived off for existing suppliers.
- h. MSME suppliers are exempt from EMD.

10. GENERAL CONDITIONS

- a. KEL reserves the right to conduct sample testing of stator frames with terminal box for 25 kW Alternator from the prospective bidder to verify compliance with the specifications and standards mentioned in the tender document. If the samples fail to meet the required specifications, the bid may be rejected or further evaluated at the KEL's discretion.
- b. 60% of the total requirement will be placed with the lowest quoted bidder on the basis of landed cost and the balance will be shared among the lowest rate accepting bidders. However, the tender inviting authority reserves the right to place order for 100% requirement on the lowest bidder. KEL reserves the right to split the tendered quantities to various bidders to meet our delivery commitments.**
- c. Tenderers will not be titled to claim any costs for preparing or submitting the bid. Firms that failed to meet previous KEL contractual obligations, resulting in short closure/cancellation (not due to KEL), or those blacklisted, are ineligible for two years.
- d. The Tenderer shall bear all taxes, Stamp duties, License fees and other such levies imposed except GST. GST will be paid extra if it is applicable.
- e. KEL may modify or amend the tender terms before the e-tender closes. Any updates, corrections, or additional conditions published on www.etenders.kerala.gov.in are binding. Bidders must regularly check the website for corrigenda.
- f. Participation implies acceptance of all terms; complaints post-submission will not be entertained
- g. Quantity indicated is approximate and will vary depending on our order position and requirements. Purchase Orders with delivery schedule will be placed as per the requirement during the rate contract period. The supplier should adhere to the delivery

schedule indicated in the P.O.

- h.** KEL reserves the right to reject any or all tenders or cancel the tender at any stage without assigning any reasons thereof.
- i.** If the performance of the work is not satisfactory, KEL have the right to forfeit the Security Deposit remitted in favour of KEL with an option to claim further damages if any, from the tenderer.
- j.** Since KEL is a public sector undertaking fully owned by the Government of Kerala, the applicable government policies, procedures and directions from time to time will also be the basis for deciding on the procurement.
- k.** Tenderers who fail to comply with earlier contractual obligations of KEL which resulted in short closure/cancellation of any contract are not eligible to participate in this tender.
- l.** The denomination of quote should be INR only.
- m.** The prices quoted by the bidder shall remain firm during the 12-months contract period. However, in case of substantial variations in the price of Mild Steel, the price variation may be considered based on the Metal Wholesale Price Index (MWPI) or documentary evidence of the actual change in Mild Steel price. Any decrease in the mild steel prices shall also be passed on to KEL, Kundara.

$$P = P_o (80\% S/S_o + 20\% W/W_o)$$

Where,

P = Revised rate of the Stator frame

P_o = Rate of the Stator frame as per the Purchase Order issued.

S = Mild Steel last available rate in MWPI

S_o = Mild Steel price rate as on August 2026

W = Consumer Price Index of Mild Steel in MWPI

W_o = Consumer Price Index of Mild Steel as on August 2026

- n. Payment for the supply will be made against receipt of the bills for the quantity accepted by us as per our records (Goods Receipt Note).
- o. The company reserves the right to accept or reject any or all the tenders without assigning any reasons whatsoever.
- p. KEL reserves the right to increase or decrease the quantity to be supplied in accordance with our production requirements for which advance intimation will be given.
- q. We reserve the right to suspend or terminate contract at any time during the pendency of the contract by giving prior notice to the supplier.
- r. Submission of false, dubious, forged or tampered documents by the tenderers shall lead to the disqualification of the tender and action as deemed fit (including forfeiture of EMD) by the KEL shall be taken against such erring tenderer.
- s. It should be clearly understood by the tenderer(s) that no opportunity shall be given to him/them to modify or withdraw his/their offer after the date & time stipulated for submission of tender. In case of modification or withdrawal of the offer by any bidder after the date & time stipulated for submission of tender, the EMD submitted with tender shall be forfeited.
- t. The tenderer has to indemnify KEL for any losses, accrued to alteration/modification made/observed in the terms and conditions, including General Conditions of the tender downloaded from the website (www.etenders.kerala.gov.in).
- u. If at any stage any change/modification is noticed in the downloaded tender document, tenderer will abide by the original terms and conditions, including General Conditions of the tenderer, failing which, KEL reserves the right to reject the tender and/or terminate the contract.
- v. KEL reserves the right to call all or any of the tenderer for clarification and seek additional information/documents.
- w. KEL reserves the right not to consider parties having any dispute arising out of any omission/ commission/ negligence etc. resulting into any type of loss to KEL during the last five years, in order to protect KELs interest. KEL reserves the right to reject any or all

tenders or cancel the tender at any stage without assigning any reasons thereof.

- x.** Any disputes, claims out of or in connection with this order shall be subjected to the jurisdiction of Courts at Kollam, Kerala.
- y.** Delayed supply attracts liquidated damages of 0.5% per week (max 10% of undelivered value), subject to force majeure, without affecting KEL's right to terminate under Risk Purchase.
- z.** If either party cannot perform obligations due to events beyond their control (e.g., war, civil unrest, natural disasters, government restrictions, strikes, epidemics) the performance timeline will be extended. If such circumstances exceed three months, either party may terminate the contract without claiming damages. The affected party must notify the other within 15 days, and proof from authorities or Chambers of Commerce will suffice. Material or financial unavailability alone is not an excuse.
